### Director's Column



India has continued to show robust economic performance for the third year in succession. The first half of the fiscal 2005-06 has witnessed a growth rate of over 8 percent. The acceleration in growth has been witnessed in virtually every sector of the economy. By all accounts, the buoyant performance is expected to continue

despite the persistence of high fiscal deficits, poor infrastructure performance, escalating oil prices and political difficulty in reforming critical areas in a coalition government. The prospects of the economy can be surmised as one of cautious optimism.

The buoyant economic performance for the third successive year has led many to believe that the economy has reached a higher growth trajectory and setting a 8-9 percent growth target for the Eleventh Plan seems no longer unrealistic. Even in the past, there have been periods of growth peaks followed by significant troughs. Furthermore, stagnancy in agriculture and slow growth of manufacturing in recent years does not signal the economy reaching a higher growth trajectory. The agricultural sector has registered a growth of just 1.5 percent during the three years of the Tenth Plan as against the target of 4 percent. *Despite impressive performance of the manufacturing sector this* year, there are serious infrastructure bottlenecks. Electricity blackouts and outages have become outrageous. Other sectors posing constraints include airports, ports, railways, and urban infrastructure. Then, there is drag from persisting fiscal imbalances. Unless agricultural growth increases to 4 percent, fiscal consolidation is achieved, infrastructure bottlenecks are eased, and institutions are reformed to restore incentives and accountability, the objective of accelerating growth will remain on paper.

The competitive populism of coalition politics and continued adoption of large unfunded programmes raise serious concerns. There are serious doubts about the capacity of the some state governments to implement many of the programmes. The important example of such a scheme is the National Rural Employment Guarantee Act (NREGA). While the issue of its desirability is no longer relevant, since the Act has been passed already, the question is how to make the implementation effective, institute a system of checks and balances and minimise corruption. Indeed, even if we are able to effectively implement

it in two thirds of the districts with a reasonable degree of success, we would have turned the economies of the lagging regions around. Can we achieve this?

Despite many apprehensions, there are rays of hope. The forthcoming budget will be a real test of the Centre's ability to withstand pressures in achieving fiscal correction. It will also set the reform direction on the eve of the Eleventh Plan.

On the fiscal front, thanks to strengthening of the information system in direct taxes, revenues have continued to be buoyant. The stagnancy in excise duty revenues is still a matter of concern and this needs to be examined. A study at NIPFP showed that over 40 percent of the excise duty revenue is contributed by petroleum products alone and this raises concerns about the distortions from taxing intermediate goods despite switching over to the CENVAT regime. Further, another recent NIPFP study estimated the loss of revenue due to tax preferences to small scale industries, area-based exemptions, export processing and special economic zones and exports from central taxes, at Rs. *54,500 crore, or, more than one percent of GDP. It is necessary* to do away with these tax preferences to raise additional resources, avoid distortions, and prevent special interest group politics. Indeed, efficiency in spending is as important as raising revenues and much remains to be done in this area.

The NIPFP will continue its role in providing research, training, and advocacy in furthering fiscal reforms and strengthening the capacity of the governments. A recent workshop on the implementation aspects of NREGA, at the request of the Administrative Reform Commission will help the Commission to recommend systems and institutions for effective implementation of the Act. The workshop on Fiscal Management in Disadvantaged States brought together senior policy makers in fiscally stressed states to discuss and devise ways and means to improve their finances while safeguarding allocation to developmental spending. The two training programmes on VAT for the officials of the state governments funded by the British High Commission and the course for the probationers of Indian Economic Service were intended to build capacity. The coming months will see the NIPFP undertaking many more challenging tasks in making contribution to research, training, and advocacy.

#### **PROJECTS COMPLETED**

 Capacity Building for Fiscal Reforms in Sikkim, Asian Development Bank, December, 2005.

### A. Premchand, M. Govinda Rao and P. R. Jena (co-authored)

The project relates to capacity building in Sikkim to enable the state to undertake fiscal reforms. The various components of the project are:

- enhancing the budgeting system;
- expenditure management and control;
- restructuring of departments to enhance efficiency;
- reforms in the tax system;
- assistance to introduce value added tax (VAT);
- public enterprises restructuring programme; and
- help in building a statistical system for measurement of the state's income and poverty.
- Toolkit for Setting a Timeline for Implementing the Urban Reform Agenda, December, 2005.

#### Om Prakash Mathur

The Jawaharlal Nehru National Urban Renewal Mission (JNNURM) requires cities applying for assistance, to lay down a time schedule for implementing the proposed reform agenda. The reform agenda consists of reforms that (i) are to be undertaken by urban local bodies (ULBs); and (ii) those to be undertaken by the state governments.

This toolkit is designed to seek information from the applicant cities that will enable the Ministry of Urban Development to set (i) the benchmarks on each of the constituents of reform agenda; and (ii) a time-schedule for implementing the reform agenda. The toolkits have been published as GoI documents and were released, alongwith toolkits prepared by IL&FS, by the Prime Minister on December 3, 2005.

• Toolkit on the Formulation of a City Development Plan, December, 2005.

#### Om Prakash Mathur

This toolkit is designed to assist city governments and other participating organisations in the National Urban Renewal Mission (NURM) such as the state-level and city-level water supply and sewerage boards and development authorities in the formulation of City Development Plans (CDPs). The toolkit outlines the scope of CDPs, as it emerges out of the NURM. It indicates the requirements of data. Further, it suggests a methodology for analysis, together with steps for their use, to assess the problems, resources, and comparative advantage of cities realistically, and to determine a medium to long term vision for their future development. The toolkit provides an approach to identifying the key issues that need to be addressed and the options that are available with city governments to bridge the gap between where the city is now and where it wishes to go.

Uttar Pradesh: Medium Term
Expenditure Policy, Resource and
Expenditure Commission, Uttar Pradesh,
November, 2005.

### D. K. Srivastava, C.Bhujanga Rao and Manish Gupta

This study examined the appropriate structure of expenditure in terms of size and composition and accordingly formulated a medium term expenditure policy for Uttar Pradesh. The study outlined the dimensions required for restructuring of expenditure in Uttar Pradesh. It covered the following areas: basic considerations in formulation of medium term expenditure policy; trends and structure of expenditure in Uttar Pradesh; expenditure policy; link between expenditure and its financing; and measures to improve efficiency of government expenditure.

The study found that the fiscal situation of the state calls for multi-dimensional reforms, augmenting tax revenues that

are distortion-minimising, reducing interest payments, curbing growth of government employment, introducing a new strategy for handling pension liabilities, revamping state level public enterprises, curbing contingent liabilities and bringing debt within sustainable limits. To achieve greater control and more effective intervention, the Fiscal Responsibility and Budget Management Act [FRBMA] provides for reducing revenue deficit to zero by 2008-09 among other targets. This would help the state derive benefits of debt consolidation and relief facility based on the recommendations of the Twelfth Finance Commission. Given the FRBMA, a seven-point strategy of expenditure reforms is suggested.

 Uttar Pradesh: Reforming the Budgetary System, Resource and Expenditure Commission, Uttar Pradesh, November, 2005.

#### D. K. Srivastava, C.Bhujanga Rao and Manish Gupta

This study examined the existing budgetary processes and suggested reforms with a view to establishing an efficient budgetary system in Uttar Pradesh broadly covering the following areas:

- outlining the budget cycle: initiation and consolidation of demands of various departments and revenue proposals;
- framework for consistency with macro and state level fiscal policy and targets;
- monitoring the quality of budget estimates;
- improving the process of appropriations and actual expenditures; and
- reforming the processes of ex-post verification and evaluation.

The study concluded that a coherent approach to budget reforms will involve binding fiscal targets; incentives for improving allocation and utilisation of resources; increased autonomy of

departments and decentralisation of responsibilities; and outcome budgeting.

 Study for Preparation of an FRBM Bill and Restructuring of State-Local Finances for Rajasthan, October, 2005.

### Indira Rajaraman, O.P. Mathur, and Debdatta Majumdar

The first part of this study involved the design of a fiscal responsibility and budget management bill (FRBM) for Rajasthan, with accompanying rules. The Rajasthan FRBM Act was finalised and enacted in May, 2005, and is fully compatible with the minimum requirements stipulated by the Twelfth Finance Commission for its conditional concessionalities. The study examines ways by which to contain infructuous expenditure, and improve own revenue collections both at state and local levels, a critical underpinning of the fiscal discipline effort. The study also looks at the larger problem of funding road development, and examines a new joint venture set up by the Government of Rajasthan with the Infrastructure and Leasing Finance Corporation (IL&FS). The draft final report was presented to all departments of the Government of Rajasthan at a workshop in Jaipur during 15-16, September. The final report was completed as scheduled by 15 October, 2005.

 Gender Budgeting: Assessment of Impacts, Ministry of Finance and Department of Women and Child Development, August, 2005.

#### Lekha Chakraborty and Kala S. Sridhar

As the Finance Minister announced in his budget speech in 2005, the NIPFP assisted the Department of Women and Child Development (DWCD) to come up with a methodological framework to assess the impact of gender budgeting on nine departments. As part of this effort, the NIPFP faculty were expert resource persons in two workshops organized by the DWCD for these nine departments and for several other departments that

have set up gender budgeting cells. The objectives of these workshops were to enable the ministries prepare a profile of their public expenditure and specify gender-disaggregated beneficiaries, conduct beneficiary incidence analysis and impact assessment, in terms of their outcomes on gender.
