### Director's Column



The challenges of continuing high growth performance in an open economy are formidable. Supported by strong fundamentals, the Indian economy has attracted significant increases in capital flows and this has posed serious challenges to the policymakers. Indeed, open capital flows, fixed exchange rates and independent monetary policy cannot co-exist. The rapid surge in capital flows

into the country has created the problem of maintaining the exchange rate at a competitive level. The sterilisation of capital inflows by the Reserve Bank of India has been at a significant cost and there is no guarantee that, even with such interventions, it will be possible to maintain the exchange rate at a competitive level. The recent months have seen considerable debate on the issue and surely, it will be debated even more intensively in the months to come. I am happy to report that the NIPFP in collaboration with the Department of Economic Affairs has drawn up a programme of research in this area of open economy macroeconomics. Hopefully, this programme will help policymakers as well as researchers to understand the problem of calibrating policies better.

It is gratifying to note that fiscal consolidation in the economy has proceeded according to the fiscal restructuring plan. The aggregate gross fiscal deficit relative to GDP declined from 9.9 percent in 2001-02 to 6.4 percent in 2006-07 and is estimated at 5.6 percent in 2007-08. The revenue deficit relative to GDP has declined from 7 percent in 2001-02 to 2 percent in 2006-07 and is estimated at just about 1.2 percent in 2007-08. Corrections have been made broadly, according to the Fiscal Responsibility and Budget Management Act at the Centre, and according to the fiscal restructuring plan recommended by the Twelfth Finance Commission at the state level.

Two important caveats must be noted to the fiscal consolidation described above. The first relates to large off-budget liabilities. The unpaid food and fertilizer subsidies and bonds issued to Food Corporation of India and fertilizer companies, mounting liabilities on the oil pool account and the huge losses of state electricity utilities together constitute an additional deficit of about 3 percent of GDP. Furthermore, as the recommendations of the Pay Commission are expected to come in the next year, when the emoluments are revised, there could be serious imbalances creeping into the fiscal situation. Another important risk is the inability of the political dispensation to pass on the increasing petroleum prices to the consumers, which could cause the subsidy burden to mount. The second notable issue

is that it is not the fiscal restructuring plan of the Finance Commission or the Fiscal Responsibility Acts of the Centre and States that have caused the fiscal situation to improve. A fiscal adjustment of almost 3.3 percentage points has been achieved due to increased revenues from income taxes and another one percentage point due to higher revenues from state taxes – particularly with the introduction of the value added tax. Another 1.2 percentage point improvement has been achieved due to lower interest payments as part of the debt swap scheme. The enhancement in income tax revenues has been mainly due to improvements in tax administration – in particular. the institution of information system by the National Securities Depository Limited (NSDL). Surely, much can be gained by entrusting the task of building the information system on the central excise also to the NSDL, instead of continuing with the National Informatics Centre which has no capacity to build the information system required for modern tax administration.

NIPFP has continued its detailed research on tax policy and administration. In particular, it has taken up a detailed study on the cost and efficacy of various tax preferences. The recently concluded seminar on Open Capital Flows had a rich fare of very well researched articles from the NIPFP faculty as well as some international experts. The work on, "Peace, Progress, and Prosperity in the Northeast: Vision 2020" has been completed and the report has been submitted to the North Eastern Council. The report was presented in several public hearings in various parts of the Northeast and discussed by the people. The study on the reform of financial management system for the Administrative Reforms Commission will be completed within the next couple of months. NIPFP has also completed the study on Fiscal Devolution to Provincial Councils in Sri Lanka at the request of the Government of Sri Lanka.

The high point of 2007 has been the capacity building programme. The NIPFP was able to train over 900 Inland Revenue officials from Sri Lanka. Besides, training programmes have also been conducted for officials from Afghanistan. There were refresher training programmes for teachers from university, and fiscal policy module training for the probationers of Indian Revenue Service, Indian Audit and Accounts Service, and Indian Economic Services. The year 2007 has been a productive one for NIPFP and hopefully, 2008 will usher in many more important initiatives in research, advocacy, and capacity development.

The main goal of the project is to formulate a common development strategy for the Northeast Region of India so that it can catch up with the level of per capita income of the nation by 2020 in a sustainable manner.

The study suggests six-pronged integrated strategy:

- i. Political and economic empowerment of the people through decentralised governance and grassroots planning.
- ii. Rural development and non-farm employment opportunities.
- iii. Developing sectors with comparative advantage.
- Capacity development of the people including skill development and institutions to design and implement development strategy.
- v. Creation of an investment climate by providing the stateof-the-art infrastructure, especially connectivity both within the region and with the rest of the world.
- vi. Ensuring adequate resources for public investment in infrastructure, and implementing a framework for private participation in investment opportunities in the region.

# M. Govinda Rao, D. K. Srivastava, Tapas K. Sen, and R. Kavita Rao

The study deals with the decentralisation in Sri Lanka, primarily with respect to provincial councils. It examines the pattern of expenditures and their financing at the provincial level, the assignment of revenue (tax) handles, and the system of intergovernmental transfers to provide suggestions for improving the equity and efficiency of the system. It argues for a better defined role of Provincial Councils in the delivery of services, a more rational and predictable system of intergovernmental transfers.

As a part of this study, two training programmes for Sri Lankan officials – one for the Provincial Councils and the other for the Finance Commission were conducted at the Institute during November-December 2007.

• Inter-State Differences in Health Expenditure: Designing and Implementing an Equalisation Scheme, World Health Organisation and Ministry of Health and Family Welfare, December 2007.

### M. Govinda Rao and Mita Choudhury

This study attempted to design a scheme for transfer of resources from the centre to states to enable the latter to provide minimum standards of health services. Specifically, two alternative approaches were explored using data from 15 major states in India. The first approach involves estimation of the expenditure requirements according to the physical norms prescribed by the Ministry of Health and Family Welfare, and other policy goals. The second approach attempts to estimate an expenditure function and use it to estimate the differences in the required expenditure in the health sector across states.

# Indira Rajaraman, C. Bhujanga Rao, O.P. Bohra, Manish Gupta, and P.R. Jena

This project funded by UNDP has the following objectives:

- i. To quantify the present state of expenditure assignment in the four states of Chhattisgarh, Madhya Pradesh, Orissa, and Rajasthan, so as to define the boundaries of functional responsibilities assigned to *panchayati raj* institutions (PRIs), and assess this against the functional devolution visualised in the Constitutional Amendments.
- ii. To assess the present status of implementation of State Finance Commission recommendations.
- iii. To assess the present status of revenue assignment.
- iv. To assess the present composition of revenue receipts by source (Centre/state/own) and thereby the present state of intergovernmental transfers.
- v. To assess the utilisation of receipts by PRIs, and thereby the state of fiscal monitoring in each state.

### A.L. Nagar, Sanjay Kumar, and Sayan Samanta

Forecast for CT and IT for 2007-08: The actual CT receipts in the first two quarters of 2007-08 are Rs. 260.58 and Rs.441.82 (both in hundreds of crores)\* respectively. Assuming a growth rate of GDP (at factor cost in current prices) to be 16 percent in the second quarter of 2007-08. The projected CT for FY 2007-08 is Rs. 1867.54 which is obtained as the sum of actual CT in the first two quarters and projected CT in the third and fourth quarters.

The projected IT receipts at the end of FY 2007-08 are Rs.995.49. Hence, the total projected revenue collections from CT and IT at the end of FY 2007-08 are Rs. 2863.03 as against the budget estimate of Rs. 2552.30.

The total projected CT receipts in FY 2008-09 are Rs. 2371.67. The total projected IT receipts in FY 2008-09 are Rs. 1265.09.

Therefore, the projected tax revenue at the end of FY 2008-09 would be Rs. 3636.76.
